The following actions are expressly prohibited by students on school property, on school buses, and at school sponsored activities:

- 2. Sale, delivery,manufacture or intent to sell deliver or manufacture lcohol, drugs ordrug paraphernalialntent may be shown by evidence of the quantity and monetary value of the substance or materials possessed.
- 3. Use, possession, delivery, sale or intent to sell or deliver-the-counter medication other substance that is believed to be or is represented as a drug or alcohol regardless of the true nature of the substance. The intent tosell or deliver may be shown by evidence of the quantity and monetary value of bove indicated substances.
- 4. Sale, delivery, or intent to sell or deliver prescription drugs. Intent may be shown by evidence of the quantity and/or monetary value of the same or materials possessed.
